Trellis Foundation has already been working on racial equity by...

- Developing mission statement that is explicit about focusing on low-income students and students of color
- Using potential to address persistent disparities as a lens when selecting focus areas
- Provide grants to organizations and programs that focus on students of color
- Support the most vulnerable and disadvantaged populations, such as justice impacted individuals, in grant making
- Support capacity building for grantees

 Acknowledges tremendous need and opportunity related to economic resilience for Texans and for the state as a whole

 Recognizes potential for intentional collaboration between higher education and workforce



RFP Priorities


- Collaboration Regional/Community Approach, may be emerging or advanced
 - Workforce Development Board, Chamber of Commerce, Economic Development Corp.
 - Education/Training Providers (community colleges, universities)
 - Community-based social services organizations, community members
 - Major employers or industry representatives



RFP Eligibility

- Location Work must take place in Texas and benefit Texas working learners
- Impact Short- and long-term
 - Responsive to COVID-19
 - Creates sustainable collaborative for educational attainment and economic development
 - Prefer a mix of student-level outcomes and community/system-level outcomes







Application Process

- All applications must be submitted through the online portal (link in the RFP document)
- Sections and descriptions are found in the RFP document – needs, plans, measures, etc.
- Required attachments include project budget and a demographic worksheet; other documents may be required as well (letters of support, 990s, audited financials)



Budget Considerations

- Trellis Foundation funds cannot be used for
 - Annual fund-raising events
 - Performances or competitions
 - Building infrastructure, physical plant, construction
 - Motor vehicles
 - Endowments or debt retirements
 - Lobbying efforts to influence specific legislation
- Up to 10% of may be applied to indirect costs.
- At least 20% of the total project costs must be covered by other funders or in-kind support



Timeline

- Proposals due by 5 p.m. (CST) on February 19
- Staff review through March
- Board consideration and applicant notification no later than March 29
- Projects may begin as early as May 1



Review Process

- Additional details may be requested by email, phone or through virtual site visits
- Anticipate that the most competitive applications will demonstrate
 - Clear understanding of workforce needs and higher education/training capabilities in their region
 - Promotion of reskilling/upskilling efforts that lead to family-sustaining wages in high-demand occupations
 - Capacity to disaggregate data by race/ethnicity and gender at a minimum



Review Process

- Anticipate that the most competitive applications will demonstrate
 - Committed partnership from multiple organizations across the community
 - Well-articulated short- and long-term goals for the work
 - Understanding of what equitable outcomes will look like for the work proposed

- + For-profit technical or academic programs?
- What constraints do you have on the funding?
- + Is the 20% match required?
